Team CESS has several academic achievements reflected in the events through the year. Collectively we had a good experience interacting with the ICSSR Review Committee which visited our Institute during 6-8 June. As we surged into the year another collective event unfolded in November: the INSEE- CESS International Conference on Climate Change and Disasters: Challenges, Opportunities and Responses, along with tenth INSEE biennial conference. Prof Ramesh Chand, Member NITI Ayog delivered the fifth Foundation Day lecture on Transforming Agriculture for Challenges of 21st Century. Two books authored by Prof R Radhakrishna were released in July. We also organized a short refresher programme on Application of Quantitative Methods for Economic Analysis for the teachers from undergraduate and postgraduate colleges in the State with the support of Telangana State Council for Higher education.

The Centre has also inked an MoU with PJTSAU (Prof Jayshankar Telangana State Agricultural University) to synergize common thrust areas of research. The Centre has undertaken the gigantic work of compiling Telangana State Gazetteer under the aegis of General Administration Department, Government of Telangana. It is first of its kind to bridge the information gap of more than a century since the Imperial Gazetteer of India Provincial Series – Hyderabad State published in 1909. The fourth batch of students in the regular PhD Programme were admitted in September which has a healthy composition of students from the State as well as all over India.

The CESS co-organised and hosted the INSEE-CESS International Conference on Climate Change and Disasters: Challenges, Opportunities and Responses during 6-8 November 2019 in partnership with the Deutsche Gesellschaftfür Internationale Zusammenarbeit GmbH (GIZ), India and the National Institute of Rural Development and Panchayati Raj (NIRD&PR), Hyderabad. The inaugural function was chaired by Prof. C H Hanumantha Rao (Honorary Professor, CESS). Prof. E Revathi (Director, CESS) welcomed the delegates. Dr Vinod Thomas (Former Senior Vice President, World Bank) delivered the inaugural address. Prof. K N Ninan (President, INSEE) delivered the Presidential address. Dr W R Reddy (Director-General, NIRD&PR), Rajeev Ahal (Director, GIZ-India) and Bhagirath Gop (TATA TRUSTS) also addressed the inaugural session.

A noteworthy feature of the conference was the plenary session where the Intergovernmental Panel on Climate Change (IPCC) organised an IPCC Outreach event where the Special Reports of the IPCC and the ongoing AR6 process was disseminated by IPCC Authors.

Prof. C H Hanumatha Rao was honoured and conferred the Lifetime Achievement Award for his outstanding contributions to agricultural economics, environmental economics and development studies. INSEE also honoured and conferred the title of INSEE Fellow on Professors M N Murty, Ramprasad Sengupta and Madhu Verma for their outstanding contributions to ecological economics. The First Bina Agarwal Prize for Ecological Economics was awarded to Prof. Joan Martinez-Alier for his contributions to ecological economics, especially on environmentalism of the poor and environmental justice.

The Valedictory Address was delivered by Prof. Gopal Kadekodi. The conference saw participation of over 200 registered participants from all parts of India and from abroad. The delegates comprised of students, researchers, practitioners and policy makers. Dr Jeena T Srinivasan (Associate Professor, CESS and Secretary, INSEE) was the Organising Secretary of the Conference.
